# Parliamentary Election – November 14, 2024

## Application for special transportation facilities by physically disabled persons

Any person who is unable, by reason of any physical disability, to convey himself to and from the polling station on foot or by any other public transport service, may under Section 83 (4) (d) of the parliamentary Elections Act No. 1 of 1981 apply by himself or by any other person on his behalf, not being a candidate, Leader of an Independent Group, authorized agent, or a divisional agent, in writing to the Returning Officer of Polling area to use a vehicle for the purpose of conveying himself to and from the polling station.

- 02. Applications for these facilities can be obtained from the District Elections Office, Divisional Secretariat, Grama Niladhari Office or www.elections.gov.lk website. duly filled application shall be submitted to the concerned Returning Officer (District Secretary/ Government Agent) or the Deputy or Assistant Commissioner of Elections of the district (District Elections Office) on or before seven days of the date of poll i.e. 07 November 2024.
- 03. The Returning Officer will be relieved if the application is accompanied with a medical certificate obtained from a Registered Medical Practitioner (Western or Indigenous) confirming that the applicant is unable to travel to the polling station by public vehicle or on foot. Such a person may obtain a medical certificate to this effect from a Government Medical Practitioner, Registered or Assistant Medical Practitioner or an Ayurvedic Practitioner. The name and registration number of the Medical Practitioner shall be stated in the Medical Certificate, if it is obtained from a private Medical Practitioner (Western or Indigenous).
- 04. Persons holding 10-year valid temporary identity cards issued by Election Commission for physically challenged persons and visually impaired persons are not required to obtain medical certificate.
