

ADMINISTRATION REPORT OF THE COMMISSIONER OF ELECTIONS FOR THE YEAR 1993

1. Introduction

- 1.1 The year 1993 is unique in the history of this Department because the department obtained its own Secretariat Building. In addition, the department also obtained on transfer from the Government Agents, official bungalows for the use of the Assistant Commissioners, at the time that the assets of the Government Agents were distributed amongst the newly created Divisional Secretariats. The department also increased its strength of vehicles to 17 in 1993.
- 1.2 The preliminaries connected with the 1993 Revision of electoral registers were organized and completed on schedule throughout the Island. However, the civil disturbances in the Northern and Eastern Provinces resulted in the disruption of enumeration work. Later on, during the period of July and August enumeration commenced in the Districts of Vanni, Batticaloa and Trincomalee.
- 1.3 During the year under review six vacancies occurred in the Membership of the Parliament, four due to resignation of Members, one due to death and the other due to the succession of the Prime Minister to the Office of the President, when the Presidency fell vacant upon the death of the then President. All these vacancies were filled in terms of the Constitution and the Parliamentary Elections Act, No. 1 of 1981.
- 1.4 Other than for the Northern and Eastern Provinces Provincial Council, nominations were called for the Seven Provincial Councils on March 18th 1993. General Elections to these Councils were held on May 17th 1993.
- 1.5 Three vacancies in the membership of the Provincial Councils, other than in the Northern and Eastern Provinces Provincial Council which stands dissolved under the Provincial Council (Amendment) Act No. 27 of 1990, were filled during the year under review.
- 1.6 Five applications pending from 1992 for recognition as political parties under Section 7 of the Parliamentary Elections Act, No. 1 of 1981, were rejected after inquiry. During the year under review ten political parties applied for recognition. Nine applications were rejected.
- 1.7 Notices of Nominations were issued on 20th August 1993 for the election of members to the Vavuniya Urban Council of Vavuniya District and all Local Authorities in the Districts of Batticaloa, Ampara and Trincomalee of the Eastern Province. These notices were rescinded by a Regulation published in Gazette Extraordinary No. 781/9 of 26th August, 1993, under Section 5 of the Public Security Ordinance. Notices of Nominations were issued again on 17th November 1993, for the election of members to the above named Councils and these notices were rescinded by a Regulation published in Gazette Extraordinary No. 794/16 of 25th November 1993 under Section 5 of the Public Security Ordinance. Notices of Nominations have been issued again on 22nd December 1993 for the election of members to Local Authorities and Nominations are due to be received during the period between Wednesday 5th and Wednesday 12th January 1994.

- 1.8 The Select Committee of the Parliament appointed in 1990 to report on the establishment of an Election Commission, had 7 meetings and lapsed due to prorogation of Parliament.
- 1.9 A Select Committee of the Parliament was appointed to consider the Reports of the Commissioner of Elections on the Presidential and Parliamentary Elections held in 1988 and 1989.
- 1.10 The Report of the Commissioner of Elections on the Second Presidential Election of Sri Lanka held on 19th December, 1988 was tabled in Parliament.

2. The Report of the Commissioner of Elections on the Second Presidential Election

The Report of the Commissioner of Election on the Second Presidential Election of Sri Lanka held on 19th December, 1988 was tabled in Parliament on 12th January, 1993.

3. The Registration of Electors Act No. 44 of 1980

3.1 *Revision of Electoral Registers – 1992*

The preparation of the 1992 electoral registers was completed on 20th February, 1993. The register so prepared was statutorily certified on 1st March, 1993, on completion of inquiries into claims and objections. The number of claims and objections received at this revision was 6,061 and 350 respectively, of which 3,197 claims were accepted and 214 objections were upheld after inquiries. Please refer Table I.

3.2 *Revision of Electoral Registers – 1993*

The revision of electoral registers for the year, 1993 commenced on 1st June, 1993. The instruction classes to enumerators were held in all the districts in the last week of May and the first week of June 1993, other than in the districts of Jaffna and Kilinochchi. The field enumeration of electors undertaken by Grama Niladharis in village areas and special enumerators drawn from the public service for enumeration in Colombo and Dehiwala-Mt. Lavinia Municipal areas, was completed in the month of September. Their work was test-checked in the field by a Assistant Commissioners of Elections and the other senior officers. The typing and the preparation of "A" and "B" lists for exhibition during the period 1st December, 1993 to 28th December, 1993 for claims and objections were completed by 20th November, 1993.

3.3 *Comparison of the Electoral Strength in Electoral Districts*

The increase in the electorate from 1991 to 1992 has been 1.125% with 10,822,142 electors. Please refer Table II for a comparative statement of the two years. However, there are differences between the Electoral Districts. It is in proportion to such changes of the electoral strength that the number of members to be elected to Parliament is determined annually, under Article 98(8) of the Constitution. Please refer Table III for a comparative statement of the electors in the 160 Polling Divisions arranged according to the twenty two Electoral Districts for the period 1983 to 1992.

3.4 *Classification of Households*

An analysis of households by electoral strength is undertaken mainly for the purpose of identifying any households with large increases. This practice which commenced in 1985 has been of immense assistance to the Registering Officers to correct any errors or stall any attempts at deliberate falsification of registers by the households. Please refer Table V for the classification of households according to the number of names in each household for the the year 1992.

3.5 *National Identity Cards*

The practise of obtaining the number of National Identity Cards at the revision of electoral registers which the Department commenced in 1984 showed an increase of 0.58% over 1991. Please refer Pable VI and VII for details on production of National Identity Cards at the annual revision of electoral registers in 1992 and a comparative statements for the years 1984 and 1992.

3.6 *Participation of Political Parties*

An opportunity is provided for all recognised political parties to nominate the agents to supervise the field enumeration of electors. However, the response of recognised political parties appears to have been limited. Pleased refer Table IV for details.

4. *Extracts of Electoral Registers*

The demand for the extracts of electoral registers arises mainly from an attempt to prove residence. However, residence is only one qualification for registration as an elector and that too is considered as ordinary residence. A person can claim to have more than one residence at a time consequent to the nature of his life and vocation. Because of this reason, the issue of an extract is always qualified by the proviso that it is not a certificate of residence. Nevertheless in the absence of the Householders list people have come to depend on the extrats of the electoral register, for proof of residence. The exposure of the electoral register, to be used for purposes other than elections, seemed to have an adverse effect on the purity of the electoral register. The one and only expectation in the preparation of electoral register is the conduct of elections. To the extent that demands are placed on electoral extracts for other purposes, such expectations get diversified. During the year under review 30,358 extracts have been issued and the total income derived was Rs. 400,694.00. Please see Table VIII for a Comparative Statement of the issue of the Electoral Extracts, during the year, 1988 to 1993.

5. *Order under Article 98 (8) of the Constitution*

The Order under Article 98 (8) of the Constitution was published in Gazette Extra ordinary No. 775/6 of July 14th 1993. This Order was based on the certified electoral register of 1992. Please refer Table XIV for the allocation of the number of members to be elected from amongst the twenty two electoral districts. Please refer Table XV for a comparative statement of this allocation from 1983—1993. The allocation based on the 1992 electoral register, has resulted in no changes in any of the districts.

6. Parliamentary Elections Act

6.1. *Vacancies in Parliament*

Six vacancies occurred in the membership of the Parliament during the year, 1993. Four of them had been created on account of resignation from the membership of the Parliament. Another vacancy occurred due to death of a member. The other vacancy has occurred as a result of the succession of the Prime Minister to the Office of the President.

In addition to the above vacancies, ten more vacancies of which eight had occurred in Jaffna District, two in Trincomalee District in the year 1990 continue to remain unfilled. Although the Group Leaders of these Independent Groups had been noticed to make the nominations, there is no response from them, as yet. Please refer Table IX.

7. Provincial Councils

7.1 *Northern and Eastern Provinces Provincial Council*

The Provincial Council of the Northern and Eastern Provinces which stands dissolved under the provisions of Section 5(3) of the Provincial Councils (Amendment) Act, No. 27 of 1990, continued to remain dissolved. Nominations for this Council called for, by Notice published in Gazette Extraordinary No. 618/10 of 11th July, 1990 continue to be annulled under the Public Security Ordinance.

7.2 *General Elections to Provincial Councils 1993*

During the year under review General Elections to Provincial Councils were held for all Provincial Councils other than the Northern and Eastern Provinces Provincial Council. Nominations were called on March 18th, 1993 for all these Councils. Nominations were received between 01.04.1993 and 12 noon on 08.04.1993. A total of 94 nomination papers were received out of which one was rejected. Nine Political Parties and Ten Independent Groups contested at these elections. The elections were held on May 17th 1993. There were 2,073 candidates from amongst the recognized Political Parties and 278 independent candidates making a total of 2,351 candidates. A total of 380 were declared elected to these Councils. Please refer Table XVII for details.

7.3 *Vacancies in the Membership of the Provincial Councils*

Two vacancies occurred due to death and one vacancy due to his being declared elected as a Member of Parliament, in the Membership of the Provincial Councils in Gampaha, Kalutara and Ratnapura Districts of the Western and Sabaragamuwa Provinces Provincial Councils. These vacancies were filled during the year. Please refer Table X for details.

7.4 *Southern Province Provincial Council*

Southern Province Provincial Council has been dissolved on 31st December, 1993 under sub-paragraph (c) of paragraph (8) of Article 154 B of the Constitution. Notice of Nomination under Section 10 of the Provincial Councils Elections Act, No. 2 of 1988 is due to be issued within seven days of the dissolution *i.e.* before January 7th 1994.

8. Local Authorities

8.1 *Term of office of the members of the Local Authorities*

After the conduct of elections to Local Authorities other than the Local Authorities in the Northern and Eastern Province in 1991 the term of office of Local Authorities, retained a two fold character.

(a) *those whose term of office commenced on the 1st of July, 1991*

This category included 257 Local Authorities in respect of which, the elections were held on 11.05.1991.

(b) *Those whose term of office commenced in 1983 and 1987 which falls into two sub-groups*

(i) Those Local Authorities which were returned uncontested in 1987, in the Northern and Eastern Province. Although the term of office of these Local Authorities were to expire on 31.12.1993, their period of office was extended to 31.12.1994, by Gazette Extraordinary No. 789/13 of 22.10.1993. This postponement brought them along with others paving the way for elections to be held for all the Local Authorities at a national level.

(ii) Those Local Authorities in respect of which no nominations were received in 1987. The Local Authorities which come under this sub-division belong to the Northern and Eastern Provinces. There were 42 such Local Authorities. Their term of office, together with those of the 13 contested and 16 uncontested Local Authorities in these Provinces, has been further postponed to the end of 1994.

8.2 *Elections to Vavuniya U. C. of Vavuniya District and all Local Authorities in the Esatern Province*

Notice of Nominations were issued on 20th August 1993 for the election of members to the Vavuniya Urban Council of Vavuniya District and all Local Authorities in the Districts of Batticaloa, Ampara and Trincomalee of the Eastern Province. In addition to one Municipal Council, there are three Urban Councils and thirty six Pradeshiya Sabhas amongst these Local Authorities. These notices were rescinded by a Regulation published in Gazette Extraordinary No. 781/9 of 26th August, 1993, under Section 5 of the Public Security Ordinance. Notices of Nominations were issued again on 17th November, 1993 for the above mentioned Councils and these notices were also rescinded by a Regulation published in Gazette Extraordinary No. 794/16 of 25th November, 1993 under Section 5 of the Public Security Ordinance. Notices of Nominations have been issued again on 22nd December, 1993 for the election of members to Local Authorities and Nominations are due to be received during the period between Wednesday 5th and Wednesday 12th Janaury, 1994.

8.3 *Vacancies in the Local Authorities*

During the current year all Local Authorities take a three-fold classification dependent on the nature of filling vacancies.

- (i) Municipal and Urban Councils the elections of which were held on 18th May, 1983, and whose terms of office were periodically postponed and finally to expire on 31st December, 1994. There were no vacancies under this category.
- (ii) Two Municipal Councils, five Urban Councils and 68 Pradeshiya Sabhas in respect of which members were returned uncontested in 1987. There were 8 vacancies in these Pradeshiya Sabhas. These vacancies have been filled during the year.
- (iii) Municipal and Urban Councils, and Pradeshiya Sabhas elected to office on 11.05.1991, and whose term of office commenced with effect from 01.07.1991. There were 178 vacancies in this category with 19 in the Municipal Councils, 31 in the Urban Councils and 128 in the Pradeshiya Sabhas. From these vacancies, 19 in the Municipal Councils, 31 in the Urban Councils and 125 in the Pradeshiya Sabhas have been filled. Respective political parties have been intimated to send their nominations to fill the other three vacancies. Please refer Tables XI, XII and XIII.

9. Recognition of Political Parties

9.1 Application for Recognition

Inquiries into five applications for the recognition of political parties, made in late 1992, were rejected after inquiry. Ten political parties have applied for recognition for the purpose of elections during the year under review. One application was accepted and the other nine were rejected after inquiry. Details of the Recognized Political Party are as follows :—

10. Referendum

The Referendum in respect of the Northern and Eastern Provinces Provincial Council which was to have been held on 28.08.1993 has been postponed to 18.02.1994 in respect of the Eastern Province and, 28.04.1994 for the Northern Province, vide Gazette Extraordinary No. 780/20 of 20th August, 1993.

11. Impact of the changes in District Administration on the Elections Machinery

- 11.1 The year 1993 witnessed a radical departure from the one-and-a-half-century old system of district administration which had the Government Agent as its administrative head. The office of the Government Agent was re-designated as the District Secretary. Most of the powers and responsibilities were devolved to a newly created office of the Divisional Secretary. With this devolution of authority, the assets of the Government Agent were also distributed amongst the Divisional Secretariat. However, this exercise of devolution was limited to the districts, outside the Northern and Eastern Provinces.

- 11.2 From the inception of our electoral system, the responsibility for the registration of electors and the conduct of elections had been entrusted to the Government Agent in his capacity as the Registering Officer and the Returning Officer. By virtue of these two statutory appointments the Government Agent became the supreme authority at the district level in all matters connected with elections.
- 11.3 The historical evolution of the office of the "Resident" who later became the "Government Agent" shows that until recent times he was most often the Magistrate, District Judge, Fiscal, Superintendent of Police, Deputy Head of Several Departments, and the Competent Authority during emergency situations. Although with the expansion in the state machinery at the district level, most of these functions were taken over by specialised institutions, this combination of functions accorded to this office, the highest degree of responsibility in the management of affairs of the District. In turn this office earned a reputation for its sense of absolute impartiality and integrity. The later day Government Agent was a successor to this respected office. The sine qua non of elections is this quality of absolute impartiality and integrity. It is in acknowledgement of the need for this quality, which had come to be highly recognized by convention that the Constitutionally independent office of the Commissioner of Elections was created in the late 1950's. As a natural outcome of this context, the registration of electors and the conduct of elections, which by its very nature is meant to be completely free of the direction and control of anyone other than the Commissioner of Elections, had traditionally been entrusted to the Government Agent of the District. Hence both by its historical evolution and as an imperative requirement of the constitution, the Government Agent became the indispensable pillar in the structure of the elections machinery at the district level.
- 11.4 The Policy statements in early 1993 on the devolution of the powers of the Government Agent to the Divisional Secretariats created the apprehension as to whether the office of the Government Agent at district level will be finally abolished. Anxieties were expressed both by the political parties and the electorate in general, regarding the conduct of elections in the event of such abolition. Unaware of the Constitutional imperatives some of them in fact thought that either the authority for the conduct of elections is also earmarked for devolution or that it should in fact be devolved as a logical corollary in the context of this devolution.
- 11.5 In the absence of any policy paper at the early stages on these proposed changes, Commissioner of Elections had to draw the personal attention of the former President on the need to safeguard the interests of the Elections Machinery. Attention was drawn in particular to the main Constitutional stipulations and the need to retain a district authority. Sri Lanka had been divided into 22 electoral districts, which were co-terminus with the Administrative Districts, except in two instances. This necessitated the retention of an officer at the District level to function as the Registering Officer and the Returning Officer. Hence no devolution below the District Returning Officer could be considered without a delimitation. If the electoral districts were to be re-carved, a Delimitation Commission was necessary. The 1978 Constitution does not provide for any regular delimitation of Electoral Districts. The appointment of any such Commission therefore requires an

amendment to the Constitution. Even if a Delimitation Commission was appointed for that purpose, so long as the system of elections was based on the principle of Proportional Representation, the Unit of an electoral district, had to be large enough to elect a multitude of members. Lest the principle of Proportional Representation cannot be sustained.

11.6 The Commissioner of Elections explained that the above requirements necessitated the retention of an officer at the district level, similar to that of the Government Agent, irrespective of the title by which he was to be designated.

11.7 Furthermore, it was also emphasized that such district officer should be adequately strong and effective to be able to command the resources of both men and material to conduct the elections. The authority of the officer should pervade the entire district. He had to be entrusted with such functions as to enable him to maintain regular communication with the district staff and be in a position to draw on the resources in a proper manner.

11.8 These requirements made it necessary to retain the office at the district level re-designated as the District Secretary. Hence the District Secretaries of seventeen (17) districts outside the Northern and Eastern Provinces were Gazetted as registering and Returning Officers of each of the district.

11.9 However the devolution of authority in respect of most other functions and the reduction of staff and the transport pools compelled the Elections Department to equip its district offices, with additional resources.

11.10 The most important change was the necessity for the district elections offices to take over all accounting and payments functions in relation to elections work. Kachcheri accounts branches had been traditionally servicing most Government Departments including the Elections Department in respect of accounts and payments. Consequent to this change, additional staff had to be provided to all district election offices. Separate Bank accounts with individual imprests, had to be opened. The Elections Department had to strengthen its own resources of staff, quarters as well as transport because the assets of the Government Agents were distributed amongst the Divisional Secretariats with almost nothing to spare, to meet our requirements.

12. Assets

12.1 *Elections Secretariat*

Most important event of the year was the construction of a separate building to house the Elections Secretariat at No. 395, Kotte Road (Sarana Mawatha), Rajagiriya, Sri Jayawardanepura.

(a) Since its inception in 1947—for nearly half-a-century this Department has been housed in rented premises in four locations in the Colombo city. With the near two-fold increase in the strength of voters in the last decade and the

different kinds of elections and their frequencies in the post-1978 period, the need for its own headquarters with adequate space and facilities, became an absolute necessity.

- (b) On the request of this Department, the Urban Development Authority offered several sites from which, the site on Sarana Mawatha was selected. This site was meant to accommodate the Elections Secretariat (Office of the Commissioner of Elections) as well as a building for a branch of the Colombo District Office. The Urban Development Authority requested the payment of an amount of Rs. 6.06 million to hand over the land. Later verification revealed that this was not a block of land on which the Urban Development Authority had spent any funds either for acquisition or improvement. It was a land managed by the Land Commissioner awaiting transfer to the U. D. A. When the Commissioner of Elections made representations to the former President J. R. Jayewardene that the above circumstances did not warrant them to seek such a payment where no cost has been incurred by them, the release of the land without any payment was ordered. Consequently the land, 0.5927 hectares in extent, was handed over to the Elections Department by the Government Agent, Colombo District on 15.11.1984.
- (c) The Department of Buildings undertook the preparation of the building plan in 1985 and it was completed by 04.01.1986. An amount of Rs. 12.0 million was estimated in 1987 for construction. But later this allocation was withdrawn due to financial constraints. Meanwhile due to cost escalations the estimates were revised. According to the revised estimates the cost of the building was identified as Rs. 45.9 million. Consequently on a request made to the late President Ranasinghe Premadasa approval was given to proceed with the construction. Funds were released in instalments of Rs. 0.4 million in 1990, Rs. 10 million in 1991, Rs. 20.2 million in 1992 and Rs. 14.6 million in 1993. There is a balance of Rs. 0.7 million to be paid in 1994. Foundation for the building was laid on 10.10.1991. Construction was completed in December, 1993 for occupation. The new building provides 28,000 square feet of office space.
- (d) Heralded by the blowing of the conch-shell and the beating of Magul-bera, the "Gevadcema" (House Warming) of the New Secretariat was performed at 10.05 a. m. on Thursday, 23rd December, 1993, with the boiling of the traditional "pot of milk". Maha Sangha, led by the Most Venerable Madihe Pannasecha Maha Nayake Thero, blessed the occasion with pirith-chanting.
- (e) Immediately thereafter, the Office of the Commissioner of Elections (Head Office) having left the fourth (during a period of nearly half-a-century) and the last of the rented-out premises at No. 2, Cambridge Terrace, Colombo 7, commenced work at the New Secretariat.

12.2 Quarters

With the emergence of the new system of Divisional Secretariats a large number of officers were transferred out of district capitals to the periphery. Assets of the Government Agents were distributed amongst the Divisional Secretariats.

The Assistant Commissioners of Elections at the district level normally depended on the Government Agents for the provision of Official Quarters as well as vehicles at the district level. With the transfer of assets, the new District Secretaries—successors to the Government Agents—were not in a position to help this Department in the same manner. Hence the Commissioner of Elections appealed to the Late President Ranasinghe Premadasa for the transfer of some Staff Quarters and general Quarters to the Elections Department for allocation amongst its staff. As a result of this appeal, the Cabinet of Ministers by decision number 1992/10(80) dated 28.10.1992 approved the allocation of Quarters. In the process seventeen staff quarters, 10 clerical quarters and 2 minor employee quarters have been transferred to this Department in the latter part of 1992 and 1993.

12.3 Vehicles

From the inception of this Department the Government Agents (now District Secretaries) who were the Registering Officers/Returning Officers had the capacity to lend vehicles to meet the requirements of the Assistant Commissioners of the Districts. With the devolution of functions of the Government Agent, he had to transfer these assets to the Divisional Secretaries. As a result he was left with only one or two vehicles. Therefore he was no longer in a position to help out the Assistant Commissioners. Hence this Department had no alternative, but to build its own pool of vehicles. Some vehicles of the Government Agents were obtained on transfer, while a few were purchased. The vehicle strength of the Department now stands at seventeen.

13. Staff

13.1 New Cadres

- (a) Government Agent handled the accounts and payments functions of several departments. Due to the restructuring of the District Administration, District Secretaries ceased to function as payment officers to other Government Departments. Consequently this Department had to undertake its own system of accounts and payments through the branch offices. For this purpose District Officers of the Department had to open Bank Accounts with an imprest, renewable at the end of each month. The additional responsibility and extra work required the appointment of additional staff of suitable seniority. This Department therefore had to increase its cadre by two additional officers to some of the branch officers to meet this requirement. Approval was therefore obtained to increase the cadre to 36 officers.
- (b) With the increase in the number of electors, the allocation of work per officer had to be revised. Work load of each officer is directly related to the number of voters and households at the annual enumeration and the number of polling stations and counting centres and the corresponding staff at elections. On this basis approval was obtained for an additional cadre of 20 (Twenty) officers.
- (c) The assets of the Department increased this year with the construction of its own Headquarters, transfer of 24 (Twenty Four) quarters for the staff, and the increase in the pool of vehicles to 17 (Seventeen). With the construction of the

Headquarters the Department is due to commence the printing and storage of the material required for elections in a regular basis, as against the ad hoc operations hitherto undertaken to meet the requirements at each election. These additional items of work necessitated the transfer of stores functions from the clerical grades to the cadre of Store-keepers. Approval was therefore obtained for two posts of Store-keepers.

13.2 *New Appointments*

(a) At the end of 1990, 53 officers of the Department retired from the Public Service under the provisions of the Public Administration Circular No. 44/90 of 18.10.1990. As the functions of this Department are statutory, there is no item of work that can be withheld or postponed. Representations were therefore made to the Ministry of Public Administration to replace the cadres. Total of such vacancies plus the increased cadre totalled 42 (Forty Two). Of this total, (Thirty Six) 36 vacancies were filled in this year. Six (6) vacancies still exist.

(b) Two Store-keepers were appointed to fill the newly created cadres.

13.3 *Transfers*

After serving the Department for eight years as an assistant Commissioner of Elections, Mr. W. A. D. U. V. Nissanka left the Department on 17.06.93 to assume duties in the Ministry of Public Administration.

13.4 *Promotions*

Mr. A. D. de Silva, Deputy Commissioner of Elections and Mr. M. C. Arunthevachelvam were promoted to Class I of the SLAS with effect from 01.01.92. and 01.07.92 respectively. Mr. M. I. M. Saleem and Mr. R. P. E. Bandara were promoted to Class I of the SLAS with effect from 01.01.93.
